

In an effort to meet the needs of transgender, gender non-conforming students, their allies and students who may feel more comfortable or safe with suitemates of different gender identifications, Residence Life & Housing offers intentionally gender inclusive housing in suite style halls. Roommates must be of the same gender identification but suitemates may be of a different gender identification. As with all housing, gender inclusive housing is NOT intended for romantic cohabitation.

**Gender Inclusive Housing Agreement Terms and Conditions**

By signing your name below, you agree to the terms and conditions of this housing agreement, which act as an extension of your housing contract.

1. I understand there are a limited number of suites that can be assigned as gender inclusive. Residence Life & Housing will make every reasonable effort to accommodate all students who have requested gender inclusive housing, but cannot guarantee to meet hall, room, roommate, or suitemate preferences.
2. I understand that I must complete all necessary steps in the housing selection process before this agreement can be signed.
3. I understand that each student entering into this housing agreement must give written consent and should commit to living in the assignment for the full academic year.
4. I understand that should a vacancy occur within the assignment, the following actions may be taken:
  - a. The remaining residents may identify an eligible student to fill the vacancy and complete a new gender inclusive living agreement.
  - b. Residence Life and Housing may identify an eligible student to fill the vacancy and all residents will complete a new gender inclusive living agreement.
  - c. Residence Life and Housing may change the assignment to a single gender and fill the vacancy accordingly.
5. Residence Life & Housing reserves the right to revoke this agreement and re-assign one or more students to another housing assignment at any time, particularly when the residents of the suite demonstrate behaviors/actions that are deemed inappropriate or in violation of the Honor Code and/or residential community standards.
6. Any student wishing to enter into this housing agreement who has not reached the age of 18 years at the time of entering this agreement must have his/her parent or legal guardian sign this document to acknowledge their approval of the housing agreement.

**Gender Inclusive Housing Agreement**

---

Gender inclusive housing at Queens allows students to choose (or be assigned) to live together as suitemates regardless of sex assignment at birth, gender identity, or gender expression. This policy exists to meet the needs of transgender and gender non-conforming students, their allies, as well as any student who would feel more comfortable and safe in an intentionally gender inclusive living environment. As with all housing, gender inclusive housing is NOT intended for romantic cohabitation.

Gender inclusive housing will only be offered in residence halls with suite style housing. Roommates must be of the same gender identification but may have suitemates of a different gender identification. For example, one side of suite may have two individuals who identify as female and the other side of the suite may have two individuals who identify as male.

Students wishing to participate in gender inclusive housing must indicate their preference for inclusive housing during their housing selection process and all students within a gender inclusive suite must give consent via the gender inclusive housing agreement. Students will not be assigned to gender inclusive housing without their explicit consent.

Residence Life and Housing will make every reasonable effort to accommodate all students who have requested gender inclusive housing, but cannot guarantee to meet hall, room, roommate, or suitemate preferences.
